In today's connected world, safeguarding digital information is just as important as safeguarding the people and children we care for, teach and work with. As providers, employers, and learners, we all share responsibility for keeping data secure and ensuring compliance with sector standards.

Top Tips for Staying Safe Online:

- Use strong passwords: Combine letters, numbers, and symbols — and avoid reusing the same password across accounts.
- Enable multi-factor authentication (MFA): Adds an extra layer of protection for platforms like apprenticeship portals and email.
- Monitor the use of digital devices as well as stop the use of digital devices when lone working.
- Be alert to phishing: Watch for suspicious emails or messages asking for login details or financial information.
- Keep software updated: Regular updates protect against vulnerabilities and ensure compliance with DfE, Ofsted and CQC expectations for secure systems.
- Handle data responsibly: Always follow GDPR requirements and your organisation's data protection policies.
- 💡 Remember: digital safety isn't just IT policy — it's part of building trust. By working together, we can ensure that our digital environment is secure, compliant, and ready for inspection.


